## **VOICE PROPOSED/DRAFT GOVERNANCE STRUCTURE**

- Co-Chairs: (4-6 Leaders; ½ Clergy & ½ Lay; Balanced Jurisdictional representation; Nominated by Strategy Team and Approved by Action Team. Rotating Terms). Roles are:
  - Organize & Chair Strategy Team Meetings
  - Public Face of the Organization
  - Relate to/hold Lead Organizer Accountable
- Executive Committee acts as VOICE's (more traditional) corporate governing body (only 6 to 8 members Co-Chairs plus Secretary & Treasurer; Nominated by Strategy Team and Approved by Action Team; Rotating Terms) with responsibilities to
  - oversee VOICE's financial & personnel management (see below):
    - 1. Formulate/Approve Annual Budget;
    - 2. Oversee VOICE's Annual Audit; Present to VOICE's Strategy & Action Teams
    - 3. Review Quarterly Financial Statements
    - 4. Evaluate Lead Organizer
  - approve significant contractual obligations,
- Strategy Team (15-20 leaders; ½ Clergy & ½ Lay; Balanced Jurisdictional representation; Nominated by Strategy Team and Approved by Action Team) acts as political strategy and policy originating body for VOICE with responsibilities to
  - do the strategic political thinking for the organization,
  - > approve governance changes, including changes to the By-laws,
  - hire/fire lead organizer,
  - appoints Treasurer/Corporate Secretary & Executive Committee
  - recommends new Strategy Team Members and Co-Chairs to VOICE Action Team,
  - conceive and recommend major campaigns/actions to Action Team,
  - set VOICEs strategic organizing priorities.
  - Determine VOICE's Dues Structure & present for ratification to Action Team, monitor and be responsible for making certain dues are paid;
  - Lead VOICE's Corporate Fundraising Campaign and assist with Foundation Fundraising.
- <u>Action Team</u> acts as the democratic membership body of VOICE and composed of 3-5 leaders from Core Teams of each member institution with responsibilities to:
  - > approve all major actions for the organization,
  - > ratify VOICE Strategy Team Members, Co-Chairs, Executive Committee/Board of Trustees nominated by the Strategy Team at the Annual Meeting of VOICE,
  - establish VOICE's dues policy and other membership requirements;
  - > lead VOICE's annual fundraiser in conjunction with VOICE Strategy team.
  - Each member institution has two votes.
- <u>Clergy Caucus</u> convenes clergy across religious and geographic boundaries for education, fellowship, and mutual support.
  - Sponsor trainings and education seminars for VOICE clergy leaders;
  - Proposes potential issues and actions to VOICE Strategy and Action Teams;
  - Relates to key religious, political, corporate, and civic leaders to build long-term relationships;
  - > Works with VOICE organizers on recruitment, leadership development, fundraising, core team development.
- Jurisdictional-Geographic Caucuses/Clusters/Ad-Hoc Issue Teams act as the strategic thinking/mini-action teams for specific jurisdictions: Alexandria, Arlington, Fairfax, and Prince William to:
  - Conceive and undertake local action;
  - Recommend county-wide actions to VOICE action team
  - Lead county-wide actions
- Annual Meeting is held 1<sup>st</sup> Quarter each year at which VOICE Strategy Team presents to Action Team the following:
  - Past Year's Organizing Accomplishments
  - Past Year's Financial Statements
  - Current Year's Budget
  - Current Vear's Organizing Drighties
